4 112 respondents aged 18+

personal interviews, online panel questionning (CAWI, 85%) and telephone interviews (CATI, 15%)





Concerns about media freedom


(% of Concerned, 2022-2025)



Compared to 2024, concerns about media freedom have grown in Czechia (by 5 pp), and Poland (by 2 pp). In Slovakia and Hungary they remained stable.



(voters of selected parties in the last legislative elections)





(average scores on a 1-5 scale)





(% of people for whom it is important to have politically independent media)




As in previous years, vast majority of people consider political independence of media to be important for society.

Opinions on the role of media owners


"Media owners have a right to tell their journalists what to write or say." (% of Disagree & Agree)



The share of people who disagree that owners have a right to control the media output has been on decline for the third year in a row (by 4-6 pp in each country)



Opinions on the role of the government


"The government has a right to influence the content of the news that is broadcasted by public service media." (% of Disagree & Agree)



Although the majority of people still support the idea that the content of public service media should not be influenced by the government, the size of this majority has notably diminished over the last three years (by 4-6 pp in CZ, SK and PL)


Opinions on the role of the government

Perceived freedom of specific media types

(average score on a 0-9 scale, 2025 vs. 2024)



Across the region, most media types are considered to be less free in 2025 than in 2024.


A sharp drop in the perceived PSM freedom in Slovakia (down to 3.1, below HU), as well as in perceived commercial media freedom (down to 3.3, below HU).

Social media and messaging apps considered to be relatively the most free media type in ALL countries.

Perceived trustworthiness of specific media types

A sharp drop in perceived trustworthiness of PSM and commercial media in Slovakia compared to 2024.


Social media and messaging apps considered the most trustworthy of all media types in Hungary.

Trust in social media in HU and CZ driven mainly by voters of opposition parties (not the case in SK and PL).

(voters of selected parties in the last legislative elections, average score on a 0-9 scale, 2025)





Strengthening of national legislation to protect media freedom









(% of Agree & Disagree)




2025: Slight decline of agreement with state's economic support for media in SK, PL and HU (by 2 pp).

Economic support by the state to protect media freedom by age





(% of Agree & Disagree)




Majority of people in all V4 countries (59%) continue to agree with EU sanctions for interfering with media freedom. The share has further dropped in the Czech Republic and Slovakia compared to last 2 years, but increased in Hungary and Poland.


The role of the EU in protecting media freedom by age











Concerns about influence of specific countries or actors on domestic media and public opinion






